OPTIONAL JUROR EXCUSAL (F.S. 40.013)

- I have been summoned and reported as a prospective juror within the last 12 months.
- I am an expectant mother.
- I am 70 years of age or older. Excuse me for this summons date only.
- I am 70 years of age or older. Excuse me permanently. (Signature required below)
- I take care of a person who is mentally or physically unable to care for themselves.
- I am a full-time federal, state, or local law enforcement officer or investigator.
- I am a parent not employed full time, and have custody of a child less than 6 years of age.
- Permanent Excusal. I am permanently incapable of caring for myself due to mental illness, intellectual disability, senility or other physical or mental incapacity. The permanent medical excusal form is required and must be signed by a licensed physician. The form is available at escambiaclerk.com/jury.

BEFORE YOU REPORT:

After 5pm on the Friday before your report date, CALL 850-595-4356 or CHECK YOUR STATUS ONLINE at escambiaclerk.com/jury TO VERIFY IF YOUR ATTENDANCE IS NECESSARY. If the automated message is not in operation or if your juror status on the web is "Summons Issued," report to jury duty as directed by your summons.

TERMS OF SERVICE:

Jury selection may take an entire day and exceed 5:00 p.m. Unusual circumstances may require you to report another day for the selection process. If you are selected for a case, your trial may begin that day or you may be instructed to report at a later date for the trial. Late arrivals will have their service deferred to a later date.

REQUEST FOR EXCUSAL/POSTPONEMENT:

The excusal request form located at escambiaclerk.com/jury must be in writing and submitted via email to juryduty@escambiaclerk.com, by Fax (850) 595-4380, or mail to Jury Management, PO Box 333 Pensacola, FL 32591. You may also use the "Other Excusal Request" area on the opposite side of this summons. The completed excusal request form must be received **five (5) business days prior** to your scheduled report date.

Requests for excusals or postponement are not accepted by phone. You will only be contacted if your request is denied or further information is needed.

PARKING INFORMATION:

Jurors should park across the street from the Pensacola Bay Center on the corner of Alcaniz and Gregory Streets. Free transportation to and from the Judicial building will be provided from this location only beginning at 7:15 a.m. until jury selection is complete. Metered parking is **not** provided. **Jurors are solely responsible for any parking fees, parking citations, or damage to vehicles or personal property.**

PROHIBITED ITEMS:

Weapons and firearms are strictly prohibited. Weapons of any kind will be confiscated and not returned. Types of weapons include: pocket knives, knitting needles, box cutters, metal nail files or clippers, scissors, guns, and other items deemed weapons under the discretion of Court Security. No liquids may be brought into the courthouse. Newspapers are not permitted during jury service.

DRESS CODE:

Business or dress attire is required. Shorts, halter tops, shower shoes, and hats are not permitted in the courtroom. Failure to comply may result in your service being deferred. Jackets and sweaters are encouraged due to temperature variations.

BEWARE OF JURY SCAMS. Please see our website for more information on a known jury scam affecting our citizens. There are several restaurants within walking distance. An ATM is located on the first floor across from the elevators.
